

Frequently asked questions - tutors

WyzAnt makes it easy to find local tutoring opportunities and manage your business. Here are some frequently asked questions about how WyzAnt works.

General questions

Q: What is WyzAnt?

A: WyzAnt is a service that helps students and tutors connect for private lessons.

Q: Is this likely to become a full-time opportunity?

A: Most tutors work a few hours a week to supplement their income and help out in their community. While there are tutors who work more hours per week, please note that it requires time and a lot of persistence to establish a large client base.

Q: How can I earn WyzAnt Rewards points?

A: With the WyzAnt Rewards program, you can earn points for completing your profile or referring new students and tutors. You can redeem your points for cash or great prizes!

Starting lessons

Q: Once I find a client, do I just show up and tutor?

A: It is your responsibility to take whatever steps necessary to make sure that you deliver a great experience for the student. Discuss some of the details with the student in advance of the lesson so you are ready to help make a difference from the very first lesson.

Q: How do I prepare for a tutoring session?

A: This is up to you, but we do have several suggestions. First, talk to the student in advance of the lesson. If time permits, try to obtain a copy of the relevant textbook, course syllabus, etc. Your local library is an excellent resource. Second, try to get repeat business! The hardest tutoring session to prepare for is the first one with a new customer. For follow-up tutoring sessions, you will know exactly what's expected and preparation will be easier.

Q: I am about to begin tutoring a new student. What do I need to do with WyzAnt?

A: Before a first meeting with a student, it's your responsibility to make sure the student has payment information on file with WyzAnt. You shouldn't have to explain the payment process to students because we explain it to them on the site and in all our email correspondence. Once you verify that the student has payment information on file with WyzAnt, you can work with the student to decide about scheduling, location, lesson duration, lesson plans, etc. Be sure to enter your hours into the WyzAnt system after each lesson so that we can charge the student and distribute the funds to you as soon as possible.

Q: Am I permitted to exchange phone numbers or Skype account information with a prospective student?

A: Yes, but only after the client has entered valid payment information. You can verify that a student has payment information on file by reading the payment status notification when sending emails to the student.

Q: Does a student have to pay prior to the first lesson?

A: No, students do not have to pay prior to the first lesson. However, before tutoring can begin (or phone numbers can be exchanged), we require that the student has valid payment information on file. No charges will occur until after the lesson takes place. Only if the student wants a discount package should he/she pay in advance.

Need to have the access to lock an account

Q: Why is there a lock next to an email in my WyzAnt inbox?

A: There are two possible reasons why the message is locked. First, the student may have entered incorrect or incomplete information when signing up. Second, we may have placed a temporary hold on correspondence between you and a particular student while we try to resolve a dispute. In both cases, we will attempt to address the situation and put you in contact with the student.

Q: You sent me an email warning that I must reply to a student, but I already replied to this student. What should I do?

A: Please take a moment to double-check your WyzAnt inbox to make sure you have no unread messages. Please also check your sent mail folder in order to verify that your response was actually sent. If the message was not sent, please try sending it again. If all these things check out, please let us know and we will look into the problem further.

Automatic emails when a student makes an inquiry

Q: Why didn't I receive notification to my primary email address that I had a new WyzAnt inquiry?

A: Please check your spam folder for the lost message and add info@wyzant.com and no-reply@wyzant.com to your address book. If the problem persists, please let us know.

Q: How do I respond to emails from WyzAnt about potential tutoring opportunities?

A: There are two ways you can receive job notices via WyzAnt:

1) WyzAnt will send you an email about a potential job opportunity. At the request of the student, we have notified several other tutors about this same job. To respond, visit the <u>Tutoring Jobs</u> page to apply for the job. You may apply

for any job post on this page as long as you have successfully passed the appropriate subject proficiency exam.

2) A student will find your specific profile while searching our site, and the student will email you directly. In this case, you can sign in to your account, follow the link to your WyzAnt email, and begin a dialogue with the interested student.

Q: Why have I not heard back from potential students I have contacted by email?

A: First, please check the "Submitted Applications" section of your profile under the "Tutoring Jobs" heading, to confirm that you successfully applied to the student's job posting. Next, please note that not all student inquiries will result in lessons. While it is unfortunate that a given student did not respond to your application, keep in mind that there are many other opportunities in your area. You may also wish to consult our How It Works page for helpful tips on how optimize your WyzAnt profile.

Q: How do I send references to potential students? The email filters prevent me from including this information in the email body.

A: In this case, please send information about your references with their respective contact information in an email attachment.

Q: Can I send my resume to a student?

A: Absolutely! Just be sure that you remove all phone numbers, addresses, and email addresses if you are sending your resume to a student that does not have billing in place.

Subject management and proficiency

Q: How do I get approved in my subjects?

A: To become approved, you have to either pass a short multiple choice test or submit a written request. You can do either by selecting <u>Subjects</u> under the "Tutor Profile" menu and following the instructions.

Q: Am I permitted to retake a subject proficiency exam if I did not pass the first time?

A: As we say explicitly on the testing page, you only have one opportunity to pass each subject proficiency test. The exams are well-researched and have proven to be fair assessments.

Q: How do I add or remove subjects?

A: Navigate to the <u>Subjects</u> page under the "Tutor Profile" menu. Click any subject in the "Your Subjects" table to view the approval status. To remove a subject from your profile, select the **Opt Out** link, A red **X** will replace the green check mark once you have successfully removed the subject. To offer instruction in additional subjects, simply add subjects to the table.

Q: When will my profile appear in search results on the website?

A: When you first register with WyzAnt, prospective students searching the site will be able to find you for all your

subjects, even if you haven't yet been approved. Even though students can find you in these subjects, you must still pass the proficiency test prior to actually giving lessons in that subject. We recommend you complete the tests as soon as possible.

Billing and payment procedures

Q: A student has asked me to give a group rate because there are two (or more) students. What should I do?

A: In this case, you can negotiate a rate change with the student. Once you have agreed on the new rate, click on the student's name anywhere in your account to view the student's page and request a rate change. Once the student confirms the new rate by email, all subsequent lessons will be billed at this rate. The standard commission structure applies to negotiated group rates.

Q: A student has asked for a lower rate and I would like to accommodate the request. What should I do?

A: You can always negotiate a reduced rate with the student. Simply request a <u>rate change</u> from the student's page and wait for confirmation from the student. If there is ever a situation when you want to offer a student a higher rate than normal (perhaps if a lot of travel is required), follow the same steps to request a higher hourly rate from the student.

Q: What is the lesson cancellation policy? How do I enter a cancellation fee into the system?

A: WyzAnt does not have a lesson cancellation policy. You can come up with your own cancellation policy and communicate this to your students *before* tutoring begins. A reasonable policy might be that cancellations within 24 hours will be billed at half rate. To assess a cancellation fee, visit the <u>Lesson Cancellation</u> page. Cancellation fees cannot be assessed more than 7 days after the date of the scheduled lesson.

Q: How do I know if a student has payment information on file?

A: When composing an email to a student, look at the notice on the top of the email. This notice will tell you the student's payment status. You can also check your student list. All students with payment information on file will appear with a green check mark next to their name.

Q: Do I have to be concerned about whether the student has paid or has enough credit for my lesson?

A: You must be sure that the student has submitted payment information before you give your first lesson. After this initial submission, we will follow up with the student if any billing issues arise.

Q: What is the commission structure?

A: When you start as a new tutor, WyzAnt takes a 40% commission of your posted hourly rate. Your hourly rate is set by you and may be changed at any time. Of the remaining portion of the fee, WyzAnt gives discounts of up to 15% to students for bulk lesson purchases and invests in marketing and software development.

A: Changing your default rate will affect, a) students who contact you after the change is made and, b) students who have not contacted you in over 90 days and who have never received a lesson from you. As an independent tutor, you have the ability to set your own hourly rate. Most tutors in the WyzAnt network charge between \$30 and \$60 per hour. You can change your default rate at any time. If you reach an agreement with a particular student to adjust your hourly rate, click on the student's name anywhere in your account to view the student's page and request a rate change.

Q: Why doesn't the name of one of my students show up when I try to submit a lesson or send an email?
A: These menus only show your current students. To manage your students, go to the <u>Students</u> page under the "Students & Lessons" menu. If you "hide" old or inactive students, their names won't be populated in any of the drop down menus.
Q: How can I receive text message alerts from WyzAnt on my mobile phone?
A: If you are interested in receiving immediate updates by text message anytime a student emails you or a new job becomes available in your area, sign up for text message alerts. Simply visit the Email Preferences page under the "Account Settings" menu and select "SMS Alerts." Please note that standard text messaging fees set by your carrier will apply.
Q: May I tutor students I find outside of the WyzAnt network? A: Yes, any tutoring you do through WyzAnt is independent of tutoring opportunities you find through other means. Any lessons you give to students you find through WyzAnt must always be logged in the system, however.

WyzAnt's tutoring marketplace

Please review these fundamental policies and procedures about being a tutor in WyzAnt's marketplace. There are a few questions at the end of the page to confirm your understanding of the material.

You're an independent tutor

As a tutor in WyzAnt's marketplace, you're in control of your tutoring business. You have full responsibility and flexibility for setting up appointments with students and entering the lesson details into the system. You select which opportunities to pursue and how much to charge. A straightforward commission structure lets you know exactly how much you make from each lesson.

Getting approved in your subjects

You can demonstrate proficiency in each subject you would like to teach by passing a multiple choice quiz or, for certain subjects, by submitting a written summary of your experience. Subjects with quizzes include most math, science, and language topics while subjects with written requests include most music, sports, and art topics.

Setting up tutoring lessons

Once you complete your profile, you will be notified of tutoring opportunities either by direct email from interested students or by finding opportunities on the Tutoring Jobs page. You can email all potential students through WyzAnt's internal email system. Before phone numbers can be exchanged or lessons provided, a student must have a form of payment on file (we accept credit/debit cards, PayPal, checks and money orders). This policy ensures that you get paid for all lessons and also helps confirm the legitimacy of the tutoring leads. Students pay you through the WyzAnt payment system for all tutoring services and WyzAnt in turn sends payment to you via direct deposit either daily or bimonthly. Payment can also be made bimonthly via check. Read more about WyzAnt's payment policies.

Attempting to receive payment directly from students will prevent tutors from achieving success on WyzAnt. When WyzAnt's algorithms identify this type of behavior, the system stops sending new tutoring opportunities.

The marketplace

90% of active tutors say WyzAnt is the best source they've found for acquiring new customers! WyzAnt's tutoring marketplace is powered by many dynamic factors such as tutoring history, responsiveness and user feedback. Our marketplace is structured to ensure that students can find the best tutors and that active tutors receive consistent, quality leads with a high student match rate. By responding quickly to new opportunities, converting leads into customers and cultivating long-term tutoring relationships, you'll set yourself up for success in the marketplace. The marketplace model is different than traditional tutoring agencies but it works! Successful tutors can make over \$50,000 per year by working with students on WyzAnt! (Some have made over \$100,000.)

Background checks

As a tutor in the WyzAnt network, you may be asked to consent to a background check if requested by a student or parent. You may also order a background check on yourself. Background checks are conducted through a partnership with First Advantage and include <u>Social Security number verification</u> and a criminal record search. In order to protect your privacy, results of a background check will only be reported to WyzAnt on a pass/fail basis in accordance with our <u>background check policy</u>.

Tutor payment and WyzAnt commission

As part of this registration, you will have an opportunity to set your default hourly rate. When you tutor any students you find in the marketplace, WyzAnt takes a commission of between 20%-40% for all lessons you have with those students. The commission varies depending on the number of hours you accumulate through the WyzAnt marketplace. Since you're independent, your portion gets distributed with no taxes or fees withheld.

WyzAnt uses its portion to give discounts of up to 15% to students for bulk lesson purchases and invests heavily in marketing to students and parents, customer support, and software development. After factoring in discounts and other transaction-related fees, tutors on WyzAnt take home 75% on average, whereas with traditional tutoring companies tutors keep just 20-40%!

Rate changes and policies

With student consent, you can change your default rate at any time and also change your rate for a specific student. When traveling a significant distance to meet with a

student, for instance, you can increase your hourly rate. Alternatively, you may want to lower your hourly rate to secure a particular tutoring opportunity. You may also wish to establish a cancellation policy to cover missed lessons. Please be sure to communicate your cancellation policy before arranging a lesson with a student. Finally, if you choose to do remote tutoring, such as via the internet, email, telephone or Skype, please obtain written confirmation from the student to your WyzAnt email address that acknowledges the nature of the work to be done and the expectations of the time and cost.

Background check information

The results of a criminal background check and Social Security number trace provide students and parents with an additional metric to consider when choosing a qualified local tutor. To provide this service to the WyzAnt community, we have partnered with <u>First Advantage</u>, one of the largest and most respected background check providers in the country, NOTE THAT WYZANT DOES NOT REQUIRE ALL TUTORS ON ITS WEBSITE TO HAVE A BACKGROUND CHECK CONDUCTED ON THEMSELVES.

How it works

As a tutor in the WyzAnt network, we ask that you furnish your name, residential address, Social Security number, and any aliases you may have. As requested by a tutor, student, or parent, First Advantage will conduct a National Criminal Database search which will return results limited to the following:

- Social Security number trace (verifying the SSN provided is a valid number and not on the death index only)
- · Felony and misdemeanor convictions within the past seven (7) years
- Sex crime convictions (misdemeanor or felony) within the past seven (7) years

Please see the Matrix which details what information may subject a tutor to removal from the WyzAnt website.

Generally, in accordance with applicable law the following convictions relating to children, theft, fraud or violence will subject a tutor to removal from the site: felony convictions within the past seven years; and misdemeanors within the past three years, except those misdemeanors relating to children which will be considered within seven years. WyzAnt, however, will review every background report and will take into consideration the nature and gravity of the offense, the time of the offense and the fact that the person is attempting to be a tutor. WyzAnt will allow an individual to dispute any inaccurate or incomplete information before removing an individual from the site.

Since the background check is only a database search, it will not cover all federal, state, and county records for adults, offenses for minors may not appear during a background check and will only cover publicly available convictions and may not cover all arrests or foreign records. Not all databases may be up to date. In order to protect a tutor's privacy, the results of a background check are only reported to WyzAnt on a pass/fail basis. Background screenings are not foolproof and they may give members a false sense of security. Background checks are not a perfect safety solution and criminals may circumvent even the most sophisticated search technology. Please refer to the Terms of use for more information.

Ordering a background check

A background check may be ordered in one of two ways. In both cases, the party ordering the check will be responsible for the fee of \$7.99. First, a tutor may elect to run a background check on him or herself. This step is optional and may expedite the arrangement of future tutoring lessons. Second, a student or parent may order a background check on a tutor. When a background check is ordered by a student or parent, failure to provide consent on the part of the tutor will be taken as an indication that the tutor no longer wishes to find tutoring opportunities through WyzAnt.

A tutor will have a "pending" status while the background check is processed and/or evaluated. Pending status means: 1) a background check is being processed, 2) a background check has been completed, but the tutor is reviewing it and has the right to dispute its accuracy or completeness, or 3) the person has a pending arrest/charge or deferred adjudication. Regardless of the reason, if a person has had a pending status for 30 days, he or she will be removed from the website.

What happens after a passed background check? We just need to be able to add an icon

Upon notification of a successful background check, WyzAnt will post an icon on the tutor's profile that details the date of the latest successful check. Students will be able to see this icon when choosing a tutor. Students and parents may also elect to run additional background checks at their own expense. When this happens, WyzAnt will communicate this action to the tutor via email and will update the tutor's profile accordingly.

What happens after a failed background check?

In compliance with the law, WyzAnt will deactivate the profile of any tutor who does not pass a background check or provide consent. Additionally, we will alert any students the tutor may have contacted while part of the WyzAnt community that the tutor has not passed the background check requirements of the site. All disputes must be directed to First Advantage at the contact information below.

When choosing your rate, consider not only your level of experience and expertise but also the cost of living in your area. Keep in mind that you can change your rate at any time. WyzAnt's commission percentage is based on the number of hours you tutor through WyzAnt, per the table below:

Q: If I'm unable to tutor a student who inquires,	can I refer the student to another tutor?
A: Yes, but only if that tutor is in the WyzAnt network.	

Q: What do I do after I give a lesson? (I would like their pay and separate to a home.)

A: After your give a lesson?

A: After you give a lesson to a student, you are responsible for reporting your hours to WyzAnt. To do this, click <u>Submit New Lesson</u> under the "Students & Lessons" menu. If your student's name is not automatically populated on this list, please click on the link that says "See More Students" at the bottom of the page. You will then enter in the details of your lesson, including the date, time, and subject covered. Once this information is submitted, we will notify the

student, collect payment, and distribute your payment minus WyzAnt's commission.

Q: I am unavailable to tutor new students right now. How do I stop receiving new tutoring inquiries? TOTALS MUST be Slowed to hive profile

A: To "hide" or "unhide" your profile from the active WyzAnt directory, you can adjust your <u>Profile Status</u> under the "Account Settings" menu. When you "hide" your profile, you will still be able to communicate and work with your current students but you will not appear in searches conducted by new students.

Q: May I use my personal email to correspond with a student once payment information has been submitted?

A: No, our policy requires that you use your WyzAnt email address for all email correspondence with your student. This also includes Facebook, LinkedIn, Twitter and other social networking sites. This is a very important policy since it protects both tutors and students in the event of scheduling misunderstandings, session cancellations, payment disputes, and rate changes.

Q: How do I edit the details of a tutoring session after it has been submitted?

A: To edit the details of a previously submitted session, go to the <u>Lessons</u> page under the "Students & Lessons" menu. Select "details" next to the lesson you wish to review and click "Edit Lesson."

Q: Why do I still see my deactivated WyzAnt profile when I search for my name on a major search engine?

A: If you have deactivated your profile, WyzAnt has removed your profile from our website. All major search engines keep an index of web pages, however, so your profile may still show up for a few days. As soon as the index is updated your profile will disappear. There is nothing we can do to expedite this process.

Q: What should I consider the start time of my tutoring lesson?

A: Unless you have an alternate arrangement with the student, please consider the start time as the time when you start the lesson. If you have to wait for the tutoring to begin, even after the agreed upon start time, please consult with your student regarding the start time that should be recorded in your lesson submission.

Q: Why is my previous hourly rate being applied to some of my prospective students after I

Q: Am I ever permitted to be paid directly by the customer?

A: No, all payments are processed by WyzAnt. If the customer offers you compensation for travel or you would like to change the hourly rate for any reason, that's fine. Simply visit that student's page in your account to request a rate change.

Q: Is there any sort of travel compensation?

A: WyzAnt does not offer travel compensation. The hourly rate you charge your customers is designed to cover the time from the beginning to the end of the tutoring lesson, not the travel component. If a student offers you travel compensation, please keep in mind that all payment must go through WyzAnt, so you cannot accept cash/check directly. However, you can adjust your hourly rate for a particular student by sending a rate change request.

Q: How do I proceed if I receive an email from a student who does not yet have payment information on file with WyzAnt?

A: Please respond to the email and answer any questions the student may have. Let the student know about your availability and see if it would be a good fit. Once you exchange a few emails and the student adds payment information, you will be able to exchange phone numbers and begin lessons.

Q: What do I do after I give a lesson?

A: After you give a lesson to a student, you are responsible for reporting your hours to WyzAnt. To do this, click <u>Submit New Lesson</u> under the "Students & Lessons" menu. If your student's name is not automatically populated on this list, please click on the link that says "See More Students" at the bottom of the page. You will then enter in the details of your lesson, including the date, time, and subject covered. Once this information is submitted, we will notify the student, collect payment, and distribute your payment minus WyzAnt's commission.

Tutoring procedures

Q: May I give a free first lesson to get to know the student?

A: We leave this to your discretion. If you wish to offer a first lesson at no charge, that is fine with us. However, the student will still need to have payment information on file with WyzAnt prior to the first meeting. In order to make sure this first lesson is free for the student, do not enter the lesson into the system.





INDEPENDENT TUTOR AGREEMENT

This is a legal agreement ("Agreement") between you, the Independent Tutor ("Tutor"), and WyzAnt, Inc. ("WyzAnt"). The parties expressly agree to transact and enter into this Agreement by electronic means within the meaning of the Uniform Electronic Transactions Act ("UETA").

- 1. Tutor Status. Neither this Agreement, the Terms of Use, nor use of the Site creates an independent contractor, employee/employer, partnership, joint venture, or franchiser-franchisee relationship between Tutor and WyzAnt. It is the parties' intention that the Tutor will be an Independent Tutor and not WyzAnt's employee for all purposes, including, without limitation, the application of the Fair Labor Standards Act minimum wage and overtime provisions, Federal Insurance Contribution Act, the Social Security Act, the Federal Unemployment Tax Act, the provisions of the Internal Revenue Code, any state income tax law, or any local income tax law, any state workers' compensation laws, and any state unemployment insurance law.
- 2. Description of Work. The Tutor will be responsible for providing tutoring instruction ("Sessions"). The Tutor will retain absolute discretion as to the manner and means of carrying out Tutor's tutoring services. Tutor shall determine Tutor's own cancellation policy.
- 3. Non-exclusivity. Tutor and WyzAnt acknowledge that this Agreement is nonexclusive and the Tutor is free to engage in and simultaneously perform any employment or other services during the pendency of this Agreement. Nothing herein precludes Tutor from advertising or providing Tutor's services to the general public.
- 4. Hours. Tutor shall set Tutor's own hours and schedule Tutor's own Sessions. Tutor shall generally render services as needed to perform Tutor's duties hereunder as set forth in the Description of Work.
- 5. Commission. Tutor determines and adjusts Tutor's own hourly Session rate. Tutor shall receive that rate less a percentage paid to WyzAnt for its services. The percentage is based on the total number of Session hours Tutor has tutored to students that have hired Tutor through WyzAnt ("WyzAnt student") as set forth in the Tutor Payment Policies.

Tutor shall be paid through the WyzAnt payment processing system for any services rendered to WyzAnt students. Under no circumstances is Tutor to attempt to seek or receive compensation directly from WyzAnt students. Prior to commencing Sessions or meeting with WyzAnt students for any purpose, Tutor must verify with WyzAnt that the student has submitted appropriate billing information. WyzAnt is not responsible for payments for Sessions given before a student has appropriate billing information on file. For student billing purposes, Tutor will report the length of each session completed through the Tutor's administrative page on WyzAnt's website (http://www.wyzant.com). If requested by the student and for their use, the Tutor will enter a summary of service performed. Subject to the review by the student of the session times submitted, Tutor shall be paid in accordance with WyzAnt's <u>Tutor Payment Policies</u>.

- 6. Payment System. Tutor agrees to abide by WyzAnt's <u>Tutor Payment Policies</u>. Tutor also agrees not to subvert the payment system or to divert funds ordinarily payable to Tutor through WyzAnt.
- 7. Expenses. Tutor is solely responsible for all costs and expenses related to the services provided hereunder including, but not limited to, expenses associated with preparing for and administering Sessions, educational materials and transportation.

 WyzAnt will not be liable to Tutor for any expenses incurred in the rendition of services.
- 8. Supplies. Tutor will provide Tutor's own supplies and equipment required to complete the tasks for which he was retained.
- 9. Taxes. Tutor is responsible for all federal, state, and/or local tax purposes. Neither federal, nor state, nor local income tax, nor payroll tax of any kind shall be withheld by WyzAnt on behalf of Tutor. Tutor understands that it is Tutor's responsibility to pay any applicable taxes.
- 10. Benefits. Tutor acknowledges that Tutor is engaged in an independent business and is not eligible to participate in any pension, health, or other fringe benefits plan of WyzAnt.

- 11. Insurance. No Workers' Compensation Insurance shall be obtained by WyzAnt for Tutor. Tutor understands that it is Tutor's responsibility to comply with the Workers' Compensation Law.
- 12. Confidentiality. Tutor acknowledges that, during the performance of services, Tutor will have access to information relating to student's identity, address, contact information, and other personal information or requests for services ("Confidential Information"). Tutor agrees that Tutor owes a duty to WyzAnt and such third parties, during the term of this Agreement and thereafter, to hold all such Confidential Information in the strictest confidence and not to disclose it to any person, firm or corporation or to use it except as necessary in carrying out the services consistent with this Agreement.
- 13. Tutor Documents. Tutor acknowledges that a copy of all documents created or received by Tutor in connection with the administration of services performed hereunder ("Tutor Documents") may be retained by WyzAnt and used for its administrative purposes. For purposes of this Agreement, Tutor Documents does not include materials solely associated with the teaching of Sessions including Session plans, notes, outlines, tests and homework and WyzAnt acknowledges these materials belong to the Tutor.
- 14. Indemnity And Hold Harmless Clause. Tutor agrees to indemnify and hold harmless WyzAnt, its subsidiaries, affiliates, and their directors, officers, employees and agents, from and against any and all losses, expenses, costs, liabilities and damages (including any legal fee and expenses), any and all injuries, whether direct, consequential or incidental in nature, which result from, are connected with or arise out of the performance by Tutor of work performed in relation to this Agreement, including any act by Tutor inconsistent with Tutor's status as an Independent Tutor.

Tutor understands that WyzAnt offers a marketplace for those seeking tutoring services to connect with those seeking to provide tutoring services. Accordingly, WyzAnt makes no representations to Tutor about the suitability, character or background of any WyzAnt user, nor does WyzAnt perform any type of background check of users. It is Tutor's sole duty to exercise Tutor's own judgment, protocols and/or standards when considering whether to engage in tutoring services with each student or client. Tutor understands and agrees that it is tutor's responsibility to conduct any and all background and reference checks regarding other WyzAnt users. Tutor is never obligated by WyzAnt to pursue any tutoring opportunity.

- 15. Site Content. Tutor acknowledges that all site content submitted by Tutor will be the property of WyzAnt and may be distributed by WyzAnt at the company's sole discretion. Such content includes, but is not limited to, articles, lessons, worksheets, quizzes, tutorials, files, testimonials, reviews, video submissions, and blog entries ("Site Content").
- 16. Term. This Agreement and the respective duties of the parties hereunder shall continue until terminated by either party in accordance with this Agreement.
- 17. Assignment. Tutor may not assign or transfer this Agreement without the prior written consent of WyzAnt.
- 18. Termination of Relationship. Either party may terminate this Agreement for any reason at any time.
- 19. Amendment. This Agreement may only be amended or modified by a writing which makes express reference to this Agreement as the subject of such amendment and which is signed by Tutor and, on behalf of WyzAnt, by its duly authorized officer. The parties agree that any amendment or modification hereunder may be transacted by electronic means within the meaning of the UETA provided that that any such amendments or modifications otherwise comply with the requirements in this paragraph.
- 20. Severability. If any term, provision, covenant or condition of this Agreement or part thereof, or the application thereof to any person, place or circumstance, shall be held to be invalid, unenforceable or void, the remainder of this Agreement and such term, provision, covenant, or condition shall remain in full force and effect, and any such invalid, unenforceable or void term, provision, covenant or condition shall be deemed, without further action on the part of the parties hereto, modified, amended and limited to the extent necessary to render the same and the remainder of this Agreement valid, enforceable and lawful.
- 21. Incorporation of Terms of Use. WyzAnt Terms of Use are hereby incorporated into this Agreement.

- 22. Terms of Arrangement. WyzAnt accepts a tutor as user for an indefinite period, subject to the provisions of this Agreement. Tutors have been removed from the website in the past for a material breach of this agreement and for a failure to follow WyzAnt's administrative procedures.
- 23. Governing Law. This Agreement shall be governed by and construed in accordance with the substantive laws, without regard to choice of law rules, of the State of Illinois.
- 24. Arbitration. Any dispute between the parties related to this Agreement shall be resolved by binding arbitration under the auspices of the American Arbitration Association and the rules promulgated by that body and before a single arbitrator chosen by WyzAnt. The arbitration shall be conducted in Chicago, Illinois, and judgment of the arbitration award may be entered into any court having jurisdiction thereof. WyzAnt may seek any interim or preliminary relief from a court of competent jurisdiction in Chicago, Illinois, necessary to protect its rights pending the completion of arbitration. Each party shall assume its own costs of arbitration.
- 25. Entire Agreement. This Agreement contains the entire agreement and understanding between the parties hereto in respect to the subject matter hereof and supersedes, cancels and annuls any prior or contemporaneous written or oral agreements, understandings, commitments, and practices between them respecting the subject matter hereof, including all prior agreements, if any, between WyzAnt and Tutor, which agreement(s) hereby are terminated and shall be of no further force or effect.
